






MANAGEMENT VERIFICATION

Managing authority / NAs

 ✓ FLC validation (nulla osta) in Italy, appointment in AL and ME by NAs

 ✓ Ensures system works: risk assessment based on-thespot, quality check
 ✓ Possible withdrawal




MANAGEMENT VERIFICATION

First level controllers main checks:

- ✓ Compliance (EU, national rules)
- ✓ Completeness
- ✓ Reality/existence and Plausibility

FLC sub-procedures :


- Inspections of documents
- Reconciliation/Recalculation
- Inquiry/interviews
- On-the-spot verifications




MANAGEMENT VERIFICATION

Joint Secretariat:

- Progress in relation to plan
- ✓ Suitable outputs / products
- Expected results reached
- Project visit (at least once with the mid-term review)

Deadlines for reporting (& controlling)

✓ Subsidy contract sets 2 reporting deadlines:


Expenditures incurred	Deadlines	Time for reporting + FLC			
01 Jan. yy – 30 Jun. yy	30 Sep. yy	60 working days			
01 Jul. yy – 31 Dec. yy	31 Mar. yy+1	60 working days			


✓ For FLC, beneficiaries have to plan sufficient time, e.g.:

Steps	Necessary time			
Beneficiary collect documents, submits report to FLC	20 working days e.g.			
FLC certifies + requests integrations etc.	30 working days e.g.			
Lead partner reports (incl. all certificates to MA)	10 working days e.g.
