Introduction

Interreg IPA CBC ITALY-ALBANIA-MONTENEGRO 2014-20

Programme results at a glance

Cooperation in the Southern Adriatic boasts an illustrious history that dates back to the earliest human migrations and trading activities in the region. Over the centuries, this spirit of collaboration has flourished, leaving an indelible mark on the area's cultural and commercial landscape. The roots of cooperation can be traced back to the time when Illyrian populations settled on both shores of the Adriatic Sea, establishing profound trade and cultural ties with the Greek and Slavic populations and cities. This exchange thrived even during the reign of the Roman Empire and Byzantium, laying the groundwork for future alliances. Throughout the course of history, various dominations and kingdoms have contributed to the ongoing cooperation in the region. From the Visigoths to the Normans, from the Swabians to the Angevins and Aragonese, from the Venetians to the Ottomans, and from the Spaniards to the French and Habsburgs, each era left its mark, fostering a sense of interconnectedness that endures to this day.

Drawing strength from these deep-rooted cultural, social, and commercial ties, European Territorial Cooperation finds a strong foundation to build upon. In more recent times, the cooperation has received a significant boost through European Union funding. Notably, the Italy-Albania programme and the IPA Adriatic programme, supported during the 2000-2006 and 2007-2013 programming periods, respectively, paved the way for the Interreg IPA CBC Italy-Albania-Montenegro in the programming period 2014-2020.

The financial support from the European Union has enabled even greater collaboration, unlocking new opportunities for the region's

prosperity and development. By capitalising on this momentum and the rich heritage of cooperation, the Southern Adriatic continues to forge a path towards a brighter and more interconnected future.

This catalogue offers a comprehensive overview of the remarkable accomplishments of the projects financed within the 2014-2020 programme. Co-funded by the European Union through the Instrument for Pre-Accession (IPA II), the programme boasted a substantial total budget of 92.707.558,00 euros, inclusive of 15% national co-financing.

Managed by the Puglia Region, this ambitious programme saw the participation from another Italian Region, Molise, as well as Albania and Montenegro, who participated with their entire territories. The programme's main objective was to foster economic growth and strengthen cooperation in the South Adriatic area. This was achieved by implementing joint initiatives between national and regional institutions, non-profit entities, and other stakeholders, with a strong focus on smart, inclusive, and sustainable development.

The external evaluators, responsible for assessing the programme's performance, acknowledged the well-balanced allocation of the budget across its priority axes. An impressive 28% of resources were dedicated to Priority Axis 2, focusing on tourism and culture, closely followed by 25% allocated to Priority Axis 3, encompassing water and energy initiatives. Priority Axis 1, centred on competitiveness of SMEs, received 20% of the funds, while Priority Axis 4, addressing accessibility, was allocated 17% of the total resources.

The external evaluators also praised the programme for not only meeting but surpassing the targets set in its performance framework. The achievements are going to leave a lasting impact on the South Adriatic region, propelling it towards a more prosperous and connected future.

The programme in numbers

The Interreg IPA Italy-Albania-Montenegro programme funded 80 projects along with 21 capitalisation actions. A total of 370 project partners from the three countries could benefit from programme funding.

100% of the programme funds were allocated, and it is expected that 100% of the funds will be utilised by beneficiaries at programme closure.

The programme funded the 80 projects (excluding TA) through:

- A standard call (2017-2022): 32 projects;
- A thematic notice (2018-2023): 8 projects;
- A targeted call (2019-2023): 20 targeted projects and 20 small-scale projects.

Additionally, 21 capitalisation actions were financed at the end of the programming period.

For Priority Axis 1 - Competitiveness, 14 projects were financed for the benefit of SMEs, and more than 70 businesses or research centres were successfully involved.

For Priority Axis 2 - Tourism and Culture, 31 projects were financed for the benefit of the culture & tourism sectors, resulting in more than 100 new products, services or pilot activities delivered to support tourism and cultural sectors. Moreover, more than 40 cultural and natural sites were enhanced and more than 20 cross-border creative platforms were established.

For Priority Axis 3 - Environment, 21 projects were financed for the benefit of the environment, and over 180 new products, services or pilot activities were delivered to support environmental initiatives. Additionally, more than 200 environmental institutions or users were involved in these projects.

For Priority Axis 4 - Accessibility, 14 projects were financed to increase cross-border accessibility, leading to the delivery of more than 20 new

products, services, or pilot activities aimed at enhancing accessibility in the region.

Building on these successes, for the programming period 2021-2027, the new programme is now called Interreg IPA South Adriatic, and it follows the exact path of the previous programme. It is also co-funded by the European Union through the Instrument for Pre-Accession (IPA III), with a total budget of 81.258.768,19 euro (including 17,51% co-financing).

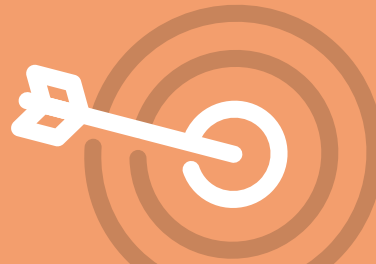

Small and Medium Enterprises account for over 95% of firms in Italy, Albania and Montenegro. They are the engine of growth, but face lots of challenges. Lack of financing is the major one.

The 3C4SME project aims to study and implement innovative approaches to credit access, enabling local public systems to transfer these new methods to Albania and Montenegro, following the successful model in Italy. Key outputs include desk research on the economic-social context in which companies operate, along with a survey on concrete credit needs of businesses. These findings are summarised in the outputs 'Pilot action' and 'Framework Agreement'. Furthermore, a law proposal has been prepared through a prototype document, laying the foundations for any legislative intervention by the territories involved.

Business registration: A transnational tool for business growth in Italy, Albania, and Montenegro.

Struggling with bureaucratic processes in cross-border business? BRE aims to create a transnational tool connecting business registries from Italy, Albania, and Montenegro, enabling the mapping and registration of enterprises, start-ups, networks, and clusters. The project designed a query platform for business registration and prepared a map of existing repositories and a database of business information, facilitating their integration with unified classification criteria. Additionally, the project delivered an analysis of existing legislation systems and provided training/mentoring activities for chamber employees. Other achievements include transnational B2B meetings, the signing of a consortium agreement for joint implementation of a new transnational course, and a foresight plan to capitalise on project results. Over 200 companies have already participated in the process.

The project established contacts between industrial and scientific entities in Italy and Albania, promoting cooperation and driving digitisation efforts among enterprises. Three international conferences and a B2B meeting provided Small and Medium Enterprises access to scientific and technological research outcomes, leading to startup creation, innovative enterprise clusters, and enhanced competitiveness. Discussions encompassed key Industry 4.0 domains, enriched by proven technological transformation experiences.

Through cross-border collaboration, we are redefining the way research and business interact in agriculture.



“We are what we eat” said ancient Romans. So how can ensure that the food industry efficiently delivers the very best products to our tables? The FILA project aims to enhance SME competitiveness and cross-border cooperation by strengthening the link between research and business. Its main results include a policy paper titled “Cooperating for Innovation in Agriculture – The European Innovation Partnership (EIP) Approach,” and the establishment of three “FILA Lab - Fertilization and Innovation Labs” in the agrifood sector, located in Valenzano (Italy), Korca (Albania), and Nikšić (Montenegro). The project has also developed an ecosystem consisting of 7 important elements (Innovation Bricks) to guide and facilitate interactions, known as the FILA Model. Additionally, the project has successfully trained 12 FILA managers and 60 innovation brokers to support its objectives.

Sustainable and innovative Agro food and fisheries value chain for MSME's cross border market

We've transformed the way we produce, promote, and connect with consumers, for a sustainable and flavourful future.



How can we harness the full potential of traditional products in the agricultural, food and fishery industry? The FOOD4HEALTH thematic project enhances MSME competitiveness and market access through improved production techniques, European quality standards, and the promotion of agri-food typical products. Key achievements include a report on best practices for quality food and consumer health, 5 community laboratories in Kotor, Campobasso, Tricase, Korca, Vlora, a technology platform for traceability of product origin, food education, innovation demand and supply, and a start-up database. A policy paper was produced to promote consumer well-being, sustainable food production, and trade. Five clusters were created to encourage joint research in the food and health sector. Lastly, 30 participants gained digital skills through a hands-on, open-innovation approach, in partnership with 20 businesses.

Pathways to success: Training the next generation in Key Enabling Technologies.

People are the driving force behind successful companies. This applies even more to SMEs, which play a vital role in the Programme area. The HISTEK project aims to create a cross-border education cluster, fostering synergies between educational institutions and enterprises, and training young people in Key Enabling Technologies (KETs). Three national clusters have been established to develop an innovative curriculum and training methodologies, leveraging digital technologies. The cross-border assessment interactive toolkit serves as a guideline for recruiting technicians trained in 5th level EQs. The assessments consist of an analysis of SMEs' needs for technicians specialised in KETs, in order to identify a profile to be trained through a new transnational short-cycle education pathway. Finally, a Consortium agreement has been signed for the implementation of the new course.

How can tourism become a sustainable source of income for Small and Medium enterprises of the South Adriatic region? The INNOTOURCLUST project aims to enhance the competitiveness and cooperation of SMEs by establishing an innovative cross-border tourist cluster that focuses on integrating and training local economic operators. The creation of this tourist cluster followed an innovative approach, combining offer analysis (an overview of the project area's tourism resources) and demand analysis (insights into the world's most significant tourism trends and needs). As a result of this analysis, eight new pilot 'travel experiences' were created, carefully aligning the supply and demand aspects. More than 80 companies have joined the cluster, subscribing to a service charter that outlines common managing principles and the shared use of a digital platform.

Are businesses ready to embrace the transformative power of Industry 4.0? The main goal of inTERaCt 4.0 is to create favourable conditions for the development of a 4.0 growth model for enterprises. The project conducted a deep analysis of the business ecosystems in the involved territories, including their growth rates, actual welfare states, and policies adopted by the governments of Puglia, Montenegro, and Albania. Additionally, an analysis of the business growth needs related to the Industry 4.0 paradigm was carried out. This information was used to develop user-side business technological platforms, which collect the genuine business needs of companies, and serve as a valuable support to define educational policies enabling their internationalisation and digital transformation. Furthermore, a technological center in Albania (HUBIM Mediterranean Innovation Hub) was established.

The small-scale project LONETA aims to enhance the administrative, industrial, and technical framework conditions for the development of new cross-border green market niches in the Programme area. Its primary focus is on fostering early-stage and pilot investments in Negative Emissions Technologies (NETs) in Puglia, Albania, and Montenegro. Through workshops, B2B events, and conferences, the project has successfully facilitated networking and collaboration among relevant stakeholders in the three countries. This collective effort has led to the development and signing of the 1st Memorandum of Understanding on NETs and nature-based solutions in the Southern Adriatic, establishing an official cooperation mechanism for these innovative solutions aimed at achieving climate neutrality and resilience.

New technologies are crucial in addressing the diseases that predominantly affect our modern society.

The PHASE thematic project aims to advance the eHealth sector in the Programme area, benefiting citizens and MSMEs by implementing innovative electronic tools and procedures. Its activities focus on efficiently treating heart attacks, neurodegenerative, and chronic diseases. The project started with a desk analysis, exploring the trends of pathologies, mapping eHealth SMEs, and addressing legal issues. It then proceeded with three pilot actions, focused on tele-cardiology, neurodegenerative diseases, and cardiovascular diseases. Finally, a capacity building phase commenced, including seminars, a start-up competition, and an international conference. Investments in a web-based platform, a control room setup, and specialised equipment were also finalised to bolster the project's objectives.

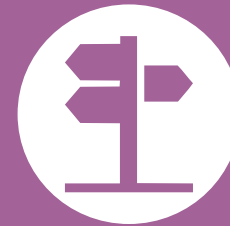

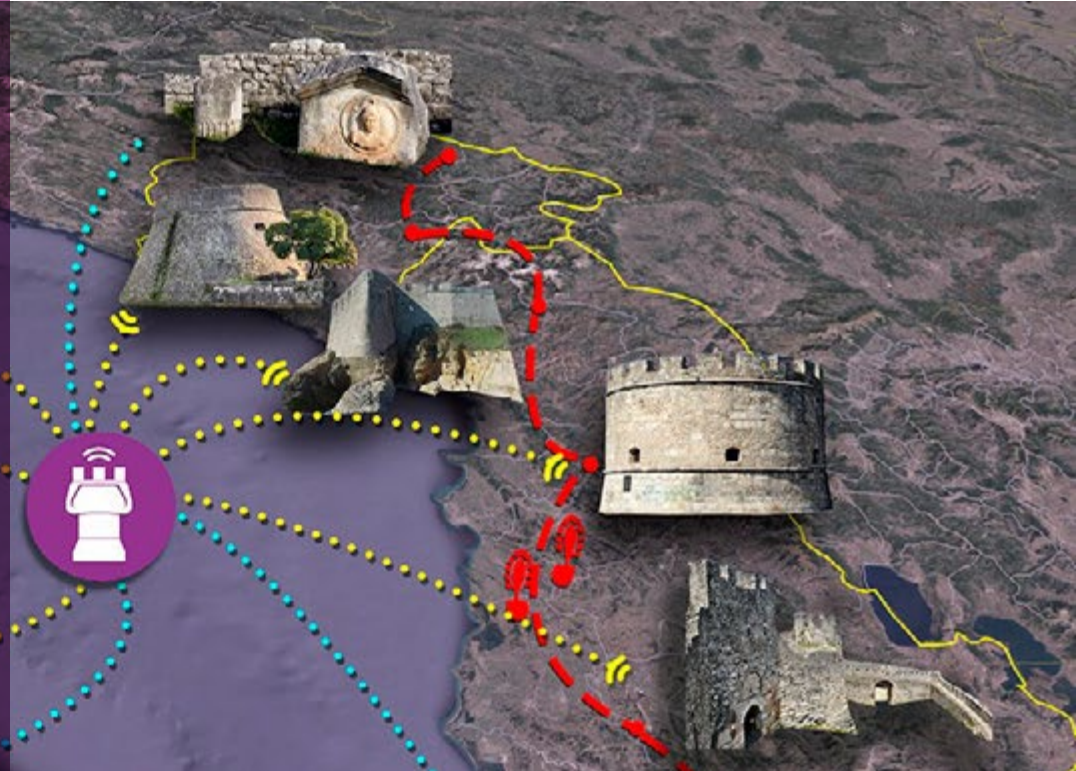

Exploring cultural heritage in virtual reality: Join us on a cross-border journey!



Can the latest 3D technology extend our perception of reality when visiting historic sites?

3D-IMP-ACT enhances cross-border smart and sustainable tourism management while promoting the protection of world heritage sites through 3D and virtual reality technologies. The project has developed a Web-GIS platform, offering online mapping of historic sites. Additionally, it has created VR/AR models, enabling immersive experiences and photorealistic 3D documentations of pilot-cases. The project has also produced 3D artefacts to facilitate inclusive access to cultural heritage, as well as 3D creative environments and objects. New laboratories were established at the University of Podgorica, Polytechnic University of Tirana, and the Albanian National Institute for Cultural Heritage, focusing on digital terrestrial and aerial photogrammetry, terrestrial laser scanning, 3D modelling, and printing.

How can we integrate the preservation of marine life with the enrichment of local communities?

BioTourS aims to transfer sustainable cross-border tourism practices, building on citizen-science activities pioneered in Taranto since 2009 for Jonian Dolphin Conservation. The project set up three Cetaceans Education Centres within existing structures in Bari, Termoli, and Kotor. This involved designing and creating exhibition content, as well as making the rooms accessible for individuals on the autism spectrum. Cross-border youth camps, combining marine research, cetacean conservation, and educational workshops, were organised in Bari, Termoli, Kotor, Vlorë, lasting 25 days in total. Activities targeted diverse youth groups, including students, young researchers, people with disabilities, and emerging tourism operators. A digital platform was also developed, hosting sighting data and geo-tagged photos of cetaceans.

Curious about the myriad treasures concealed within the natural underground cavities of the Adriatic area? The CAVES small-scale project aims to nurture the speleological tourism sector by developing two new itineraries in Albania and establishing a cross-border network for exchanging experiences, skills, and best practices. Three key actions were executed, including an educational workshop in Crispiano, a B2B meeting in Tirana, and a final seminar at the Castellana Caves. This collective effort resulted in a joint transnational strategy for sustainable speleological tourism, with contributions from Montenegro. The project engaged 10 NGOs, 10 SMEs, and 2 research organisations, while producing two guides on speleological sites, including Pellumbasi Cave (also known as Black Cave), and Holta Canyon and Kabashi Cave (also known as Farrica Cave), both located in Albania.

Co.Co.Tour aims to secure smart, inclusive, and sustainable growth for coastal communities in the Programme area through the development of a cross-border eco-museum model and a common strategy focused on community tourism. The project conducted a territorial analysis of the municipalities of Herceg Novi, Himara and Tricase, and created guidelines for the 'Eco-museum cross-border model.' It also organised training sessions, developed a touristic package combining public and private interests in the tourism market, and implemented two new eco-museums in Himara and Herceg Novi. Small investments were also made to install ICT tools in the eco-museum areas, improving the smart usability of the heritage and transferability of stories. The project culminated in the creation of a web and ACCESS PORT App linked to the three Eco-Museums.

In every wave, we find inspiration to redefine nautical tourism, enriching every season.



Beaches of the South Adriatic region are overcrowded in Summer, while coastal and inland areas have more to offer all-year-round. The objective of REGLPORTS is to develop a shared model and plans for enhancing Nautical Tourism in the Programme area. The key outputs encompass a cross-border nautical tourism development plan (including data collection, SWOT analysis, thematic routes enhancing coastal and inland areas, and an interactive GIS application); an IT platform featuring common tourist services; pollution monitoring installations achieved through the acquisition and development of a Port Monitoring System, which is tested in two ports (Termoli and Herceg Novi); tools for upgrading tourism skills, and an e-learning platform tailored for tourism professionals, providing them with training materials, suggestions, and best practices.

ICT for Smart Healthcare to Tourism

Dedicated to creating a world where everyone can explore and enjoy without barriers.

Ever worried about accessing medical services while travelling abroad? Or wondered about the availability of targeted touristic services for people with disabilities? The WISHFUL project aims to reduce access barriers for tourists suffering from chronic conditions and/or disabilities by implementing a network of tourist and medical services. Outputs include creating a target community through the identification of user experience models, analysing requirements for mapping touristic and medical structures, developing statistical and sentiment algorithms, and a data visualisation dashboard. The project developed an interregional healthcare tourist network on an IT platform to create tourist offers tailored to users' medical needs and created three cross-border touristic route solutions. Furthermore, it focused on the valorisation of a historical site in Maglie, improving accessibility for different types of disabilities.

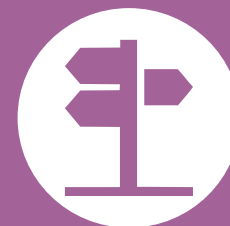

Culture: The heartbeat of progress, uniting creativity and collaboration across borders.

Cultural industries have proven to be invaluable assets for regional development. The 3C project fosters cooperation among cultural and creative industries within the Programme area. The project invested in innovative centres in Albania (Kinostudio and Park of Art), Italy (Palazzo ex GIL in Campobasso, Regional Library-Museum Pole of Bari), and Montenegro (Old Prison Building in Kotor). Additionally, it organised three arts mobility and visiting programmes in each region. Target sectors encompass Design, ICT (video gaming), and Modern crafts, while the subsectors include “The City of lights” (Video art and 3D mapping); “Music roots”; and “Cultural memory” (contemporary theatrical expressions). A web platform was also developed to enhance networking among cultural and creative enterprises and provide information about the cross-border region’s culture and creative sector.

Theatre, an ancient art form, continues to embody the vibrant cultural heritage of a region, its people, and their traditions. The ADNICH project strengthens cross-border collaboration by harnessing the intangible assets of the Programme area, creating immersive cultural experiences. Embracing a bottom-up approach, the project fosters fruitful partnerships between academic and cultural institutions. The beauty of the Southern Adriatic lies in its rich biodiversity, yet marine pollution and overexploitation threaten this unique ecosystem. ADRINET enhances a joint coastal management system and establishes governance plans to preserve biodiversity and coastal ecosystems within the Programme area. Addressing common challenges like pollution, over-exploitation of fish stocks, illegal fishing, fish sophistication, and 'ghost fishing,' the project contributes to safeguarding the region. Scientific studies have provided valuable data, including reports on sea conditions, best fishing practices, and environmental risk management plans. Pilot actions carried out by local partner administrations involved removing ghost-nets and creating a traceability system using RFID technology, fostering engagement with fishermen and local communities.

Just like the ocean is made of tiny drops of water, protecting our environment requires collective efforts. The BLUE LAND project's main goal is to develop and implement a participatory and ecosystem-based model for safeguarding marine and coastal resources, habitats, biodiversity, and ecosystem services. The project successfully achieved its objectives by producing a strategic document, conducting regulatory legislation analyses, and creating innovative ICT products. These products include a web-based geoportal for interactive visualization of spatial data collected from three selected areas (Porto Palermo in Albania, Tricase in Italy, and Velika Plaža in Montenegro), as well as a native smartphone app available in four languages. Additionally, the project activated three pilot initiatives, further advancing its mission.

Life on earth is only possible because of water. Our bodies are 60% water. These two facts alone compel a wise use of this vital resource. The CrossWater thematic project aims to establish an efficient and effective cross-border water management system in the Programme area. To achieve this goal, a Water Management System Plan and a shared Policy Paper with guidelines for improving local water management plans in a sustainable and eco-compatible way, were developed. The project delivered four pilot technical projects, including a monitoring system for the biological sector in two treatment stations in Puglia, the construction of a water supply network in an Albanian village, an integrated system for improved performance in Molise, and the installation of specialised equipment in Montenegro. Additionally, technical-scientific activities and an awareness campaign to reduce wastewater were carried out.

Flood and landslide assistance and training

Empowering communities to withstand the forces of nature, together we build resilience.



In case of heavy rainfall, floods and landslides can pose significant threats. The key lies in effective risk management planning. The FLAT project aims to improve institutional capacity and establish an effective flood and landslide management system in the Programme area. Project outputs include the establishment of a regional resource centre in Danilovgrad, equipped for trainings on floods and landslides; provision of rescue equipment to the Municipality of Nikšić and Montenegro mountain rescue service; a GIS system for monitoring coastal erosion in Brindisi; three joint documents analysing the current situation, providing recommendations for protection and risk mitigation, and offering a practical guidebook for action; two knowledge improvement workshops, and a web platform for real-time information sharing to enhance cooperation during hazardous events.

How can we safeguard endangered species from the threats of climate change and human activity?

LASPEH project takes action to combat the loss of biodiversity by developing a collaborative strategy to preserve the natural heritage and landscape of the low Adriatic area, with a focus on protected species. Through scientific research, project partners have created a joint strategic plan and conservation measures. They have implemented a set of concrete actions, such as the reclamation of the Quirino torrent canyon, installation of information panels and training meetings in the Natural Regional Park of Coastal Dunes, monitoring activities by the Municipality of Ugento and the Litorale Tarantino reserve, and habitat revitalization led by the Public Enterprise for National Parks of Montenegro. The National Agency of Protected Areas of Albania has installed explanation tables and a viewpoint for observing the Tetrao Urogallus.

Climate change demands cross-country collaboration to address emergencies arising from extreme weather conditions, fires, and floods. The TO BE READY thematic project enhances prevention and preparedness measures for natural and man-made disasters, improving safety in the Programme area. This is achieved through the acquisition of facilities and equipment (e.g., field hospitals, satellite products, sensors), improving the skills of operators involved in risk prevention through training and practical exercises, and conducting scientific and communication activities (e.g., operational procedures, bulletins). Other project outcomes include obtaining certifications, developing a Geographic Information System (GIS), and creating mobile applications (APPS) for civil protection.

Through creative innovation, we reimagine our relationship with the sea, paving the way for a cleaner and more beautiful coastline.



When we want to enjoy a beach during our holiday time, we become particularly sensitive to marine litter that mars the beauty of the landscape. The WELCOME project supports the long-term management of marine litter (ML) and promotes sustainable development through innovative approaches, including the artistic reuse of wood ML. Throughout the project, beach cleaning operations were conducted in Italy, Albania, and Montenegro, with a video reportage capturing the efforts. An artistic competition was organized to create dune protections using natural beached garbage, mainly wood. The winning project was then implemented to restore dunes and protect sandy areas in Italy and Montenegro. Moreover, the project developed a comprehensive cross-border ML management plan and legal framework to effectively address the ML issue.

Are our cities prepared for the challenges of climate change? ADRIA_Alliance aims to transfer know-how, focused on increasing energy efficiency in buildings and enhancing the safety of cities against climate change risks. Main outputs include four LABs for renewable energy communities, a series of awareness events, meetings with local governance systems highlighting business opportunities, and two energy forums in Campobasso and Tuzi to encourage municipalities' adhesion to sustainable energy and climate action plans (SECAPs). Notable pilot actions were implemented in Fossalto and Tuzi (schools), Malesi and Madhe (eco-camp houses), and the Union of the Municipalities of Grecia Salentina (a panoramic power centric business). As a result, 19 municipalities formally adhered to the Covenant of Mayors, and five SECAPs were approved.

“Nothing is lost, nothing is created, everything is transformed” – declared the French chemist Antoine Laurent de Lavoisier. AWeSOMe aims to raise awareness about fully sustainable building materials crafted from agricultural waste. The project began with an analysis of the local agro-waste’s status, followed by an assessment of prototype physical properties. These efforts demonstrated the secure utilisation of agricultural waste in construction through distinct and complementary methods. Furthermore, the installation of one prototype each in four public buildings within the involved regions was executed, accompanied by monitoring activities. Ultimately, the partners orchestrated public self-building workshops to illuminate the potential and advantages of the proposed technologies.

EFFECTS aims to tackle the energy efficiency challenge within school buildings, evaluating potential intervention strategies to mitigate their environmental and climate impact. The achieved outcomes include an energy system assessment to analyse crucial protocols for building energy efficiency and establish tailored adaptations for schools, a comprehensive census tool and an online virtual hub for resource aggregation. Pilot interventions were executed in De Nittis School in Barletta, Montecarlo School in Termoli, Kindergarten n.11 in Vlora, and 25 Maj School in Tuzi. Finally, capacity-building initiatives were conducted utilising both a bottom-up approach (with schools) and a top-down one (with public bodies), culminating in the delivery of optimal energy efficiency practices for schools.

Amidst the urgent need for more sustainable air travel, how can airports take meaningful steps towards reducing their carbon footprint? SOLAR is dedicated to developing precise tools for measuring the carbon footprint of airports in Puglia, Albania, and Montenegro, while also initiating effective policies for the reduction of carbon emissions. The project has produced a carbon footprint report to detect, account for and report CO2 emissions, a low carbon/low energy plan containing possible strategies to reduce carbon footprint in the airports, and a study on environmental impact of connections between Puglia and Molise. Moreover, awareness and behavioural change campaigns for promoting sustainable management in involved airports, as well as training campaigns on energy efficiency and carbon management techniques were held. All actions have resulted in the creation of a joint toolkit for sustainable management of CO2 emissions in airports.

Would cities be better places with fewer cars on the streets? There would certainly be less pollution, less noise, less stress, and life would become more enjoyable. #DynaMob 2.0 promotes environmentally friendly modes of transportation in the Programme area, with a focus on electric car and bike sharing. The project realised its goal through the development of a mobility smart application (DynAPP), which monitors traffic peaks and road conditions. Local information and inputs were collected, leading to the finalisation and dissemination of an integrated action plan. Municipalities selected two roads exclusively for sustainable mobility, and informative signs were placed along these routes in Copertino and Campobasso. Moreover, the project facilitated the acquisition of e-bikes and the establishment of bike-sharing/eco-car point infrastructures in Budva, Campobasso, and Copertino.

Cross-border RISK management of hazardous material transportation

With cutting-edge technology, we are advancing towards safer and more efficient transport of hazardous materials.

Hazardous materials always pose a risk. How can we ensure their safe transportation in a cross-border area? CRISIS aims to comprehensively study the risks linked to hazardous materials within the Italian, Albanian, and Montenegrin territories, as well as their road transportation in the surrounding area. The project's main outputs include identifying precise risk measures that address key aspects of hazardous material transportation in the Programme area, creating a multimodal safest routing algorithm for transportation, and developing a berth allocation algorithm. Additionally, the project successfully designed an advanced ICT platform to monitor and facilitate decision-making regarding the transportation of hazardous materials in the region.

How can advanced information systems revolutionize intermodal flows in Southern Adriatic ports?

EFINTIS aims to increase the efficiency of intermodal transport flows in the Programme area by upgrading management information systems. Through the project, existing ICT systems and platforms of the involved partners have been developed for the first time or upgraded and optimised. These ICT tools enhance services' digitisation in the participating ports, streamlining administrative activities and reducing processing time. Prior to implementing the pilots, EFINTIS conducted a "Report on the state of the art in involved ports," followed by an "Action plan for development of the ICT connection," adapting the findings to the potential and capacity of each region. Moreover, a Memorandum of Understanding was signed by all project partners.

Innovative Systems to enhance Antifraud Customs Controls

Streamlining customs: Advancing efficiency and transparency for secure trade.



Optimising customs procedures and anti-fraud measures in the cross-border area between Italy, Albania, and Montenegro is urgent. ISACC aims to define information methodologies, models, processes, and structures to introduce innovative approaches in the anti-fraud inspection and control phases. The project built an international network of public institutions and conducted research and studies on custom procedures and antifraud measures. A customs 'footprint' has been created, consisting of a pilot digital form with information and parameters of a good, aimed at verifying the invariance of the generated information through automatic data analysis systems and geo-tracking. The project was completed with capacity-building actions to enhance the operational, administrative, and technical/IT capacities for customs officials and private transport operators.

Key project outcomes include the development of a strategic plan for the transnational passenger transit system, a pilot action to harmonize equipment and software for smoother embarkation and disembarkation in Lower Adriatic ports, a bottom-up research study on passengers traveling along the eastern and western coasts of the Lower Adriatic, and a joint study to improve multimodal connections within the Programme area. A memorandum of understanding has also been signed, involving transport authorities and regional stakeholders.

Empowering cross-border travel is the key to unlocking a connected and accessible future.



Albania and Montenegro are only 150 km away from Italy's heel, but have you ever tried to reach the country just across the sea? The ON CLOUD NINE project aims to enhance sustainable cross-border connectivity through an integrated transport model that improves multimodality and accessibility to airports. Despite COVID-19 challenges, the project adapted its actions to ensure progress. Aeroporti di Puglia increased flight frequency to Albania through specific contracts with WIZZAIR. Molise Tour conducted a pilot action for interregional road transport, aligned with the Bari-Tirana round-trip flights in Summer 2022. Furthermore, project partners invested in vehicles and equipment to strengthen COVID pre-screening measures, and improve accessibility and services at airports. This includes screens, re-charging stations, and devices catering to the needs of disabled passengers.

Charting the course to progress: A multimodal transport model for growth in the Southern Adriatic.

There is no magic wand to make vehicles disappear from our highly congested roads. We need alternative and sustainable solutions, such as maritime transports. The project PORTS aims to strengthen the Apulian Sea links with Montenegrin and Albanian coasts to support the socio-economic growth of the area. To achieve this objective, the partners delivered the following: a needs analysis for cross-border accessibility, involving an analysis of the state of the art of sea highways and routes in the Adriatic-Ionian region; a mathematical transport model that examines the current state of the logistic Ionian-Adriatic Corridor, providing users with a multimodal transport network chart illustrating possible connections for various modes of transport. Additionally, an online training webinar was disseminated using two different platforms, tailored to the specific interests of the target audience.

Sustainable Mobility in the Port Cities of the Southern Adriatic Area

Embracing sustainable mobility in port cities: the path to a greener future begins.

Imagine a world where sustainable transportation reigns supreme, reshaping the way we move in port cities! The SUMO project enhances sustainability and mobility in key port cities of the Programme area by promoting alternative modes of transportation to cars, such as hybrid/electric motor boats, buses, and bicycles. To achieve this goal, four pilot actions were implemented: 1) an electric catamaran was purchased to provide more sustainable passenger transport in the port of Brindisi; 2) a hybrid bus was acquired to improve public transportation in the port area of Bar; 3) a cycleway was developed to connect the port of Vlora to the city centre; 4) two Variable Message Panels were installed near the port area and railway station in Termoli. Furthermore, a cross-border development plan was devised to promote sustainable and multimodal urban mobility systems.
