- The MC approves the scores in the ranking list.
- The MC approves an additional allocation of 1.790.000 in order to finance entire and one additional project for P.A. 1 and 5 and two project proposals for P.A. 2, 3 and 4. The necessary additional funds, to be fixed upon the negotiations, are provisionally shifted from the allocation to the last SSP call.
- The MC gives the mandate to MA/JS to hold negotiations to optimise the project activities and budgets, considering the comments by the Steering Committee, the ongoing indexation of SCOs to inflation and project specific conditions, but NOT exceeding the total amounts requested, for further approval of the final budgets by the MC.
- For projects no. 072, 100, 169, 178, 176, 114, 002, 073 the MC recommends a consultation with the respective national authorities during the negotiation phase, as to ensure administrative / financial capacity of partners, incl. prefinancing and co-financing capacities.
