



PUBLIC CALL
for identification and selection of music and performance artists

Background

This public call is realized within the project “Cross-border exchange for the development of Cultural and Creative industries – 3C (number 354, s.o. 2.2.)” which is implemented under Interreg IPA CBC Programme Italy - Albania – Montenegro. The project aims at enhancing cooperation between CCI actors in the project area, through the creation of innovative centres with residential arts programmes and joint cross-border cooperation networks. The core results are the introduction of a Regional Arts Mobility and Visiting Programme, the opening of four multifunctional cultural centres in Montenegro, Italy and Albania and the establishment of a cross-border network of cultural entrepreneurs.

Aim of this public call

Artists from Montenegro, Albania and Italy (from Puglia Region and Molise Region) will take part in a two-week workshop (approximately from the 06th to the 12th of March 2023 online and from the 20th to the 26th of March 2023 in person, unless changes that will be promptly communicated) hosted in the rationalist-style palace named “GIL” in Campobasso (Molise Region).

The aim of the workshop is to create and produce a contemporary and experimental piece of music inspired by the local musical heritage and to the local bagpipe, in Italian “zampogna”. It will also be realized a video clip inspired to the music composed and the selected artists will be part of it. The video clip will be publicly presented during a final exhibition which will take place in the project’s countries in April 2023.

Who can apply?

Applicants are artists specialized in the following areas of expertise:

- Musicians/composers,
- Video makers,
- Performers.

The call is addressed to all musicians/composers with regard to those who use traditional local instruments.

All applicants have to present the following documentation:



1. **Professional or artistic CV;**
2. **Manifesto** with their own envisioning of the project that they would like to realize, taking in mind the aim of this public call (1200 characters spaces excluded).

Submitting application

All candidates must submit their application, penalty of exclusion, by the **8th of February 2023 at 12:00 local time**. Only the applications received not later than the 8th of February 2023 at 12:00 local time will be accepted. Application documents must be in English.

Selection procedure

An evaluation committee constituted by representatives of Molise Region and of Fondazione Molise Cultura, which will be appointed after the launch of the call, will create a list of candidates from Montenegro, Albania and Italy (Puglia Region and Molise Region). The evaluation committee will consist of professionals in relevant fields of the project.

The evaluation of the candidates will be carried out according to the following criteria:

Professional and artistic CV	4 points
Manifesto	6 points
Total score	10 points

Within this call the evaluation committee will select a maximum of 2 candidates from Montenegro, 2 from Albania, 2 from Puglia Region (Italy) and 4 from Molise Region (Italy) of which at least 6 musicians/composers.

The organizers will cover the accommodation costs in Campobasso (Molise Region) for the selected candidates from Montenegro, Albania and Puglia Region (Italy) for the period of the workshop; for them travel costs will be covered by 3C project partners from respective countries/regions. For the 4 participants coming from Molise Region will be recognized a refund of transport costs (only for non-residents in Campobasso) and lunch, if documented in accordance with current legislation on expenses.

Privacy policy
